## Inherit hazards

The purpose of this letter is to prevent accidents by informing our clients of some of the hazards so you can prepare yourself to minimize your risk.

In our business there are many risks. Horses are a big part of our business. Riding horses can be hazardous. We can't always predict what they will do. We use very well trained horses that have good performance records. We have horses that match all types of riders from the novice rider to the experienced rider. We do our best to match the riders' skill to the horse skill level. Even the calmest horse can have unpredictable behavior.

A horse is a flight animal and might dart, this a very fast movement in any direction. Horses can also lose their footing and cause them to stumble and possibly fall. They may come across something that they feel compelled to jump instead of stepping over. The list of things that can go wrong is numerous. That is why we keep well-trained horses to minimize the risk of accidents, it is very important to determine your skill level. Wind River Outfitters can not guarantee how our horses will perform.

## Basic Riding Skills

### Mounting & Dismounting

It is important that you always have the reins in your hand while mounting and dismounting to ensure control of the horse. If assistance is needed make sure your guide is there to help you. Our horses can be mounted or dismounted on either side.

**In steep terrain you always mount and dismount on the uphill side of the mountain.**

Foot placement in the stirrup: Place the ball of your foot on the stirrup. **Do not** put your foot through the stirrup; this could cause your foot to get hung up in the stirrup.

**Always** keep both feet in the stirrups. **Do not** dangle your feet along side the horse.

**Do not** sit sideways on your horse.

**The Saddle:** Your horse will be saddled when you receive it. Horses are known to suck air into their lungs while saddling; this makes it very difficult to tighten the saddle. If the saddle feels loose when starting to mount or after riding awhile the saddle sometimes will become loose. Make sure you inform your guide they will tighten it for you.

## IT IS IMPORTANT YOU REPORT ANY LOOSE SADDLE

**CHILDREN:** Are not to be tied into the saddle at any time. Riding double will not be allowed at anytime. If you have any questions please feel free to ask. It is important to us that you have a great outdoor experience. We believe that the best way to avoid accidents is to be educated in what might happen. This way you can be prepared for it and take corrective action if needed.

## ACKNOWLEDGEMENT OF RISK

I recognize that there is an element of risk in any adventure, sport, or activity associated with the outdoors. I am fully aware of the risks and dangers inherent in horseback riding and have been informed of known & special hazards in such activity. I certify that my family and I, including minor children, are fully capable of participating in said activity.

Therefore, I assume full responsibility for personal injury to myself and/or members of my family, of for loss or damage to my personal property and expenses thereof as a result of my negligence and/or the negligence of my family participating in said activity except to the extent such damage or injury may be due to the negligence of **Wind River Outfitters**. I further understand that **Wind River Outfitters** reserves the right to refuse any person it judges to be incapable of meeting the requirements of participating in horseback riding.
